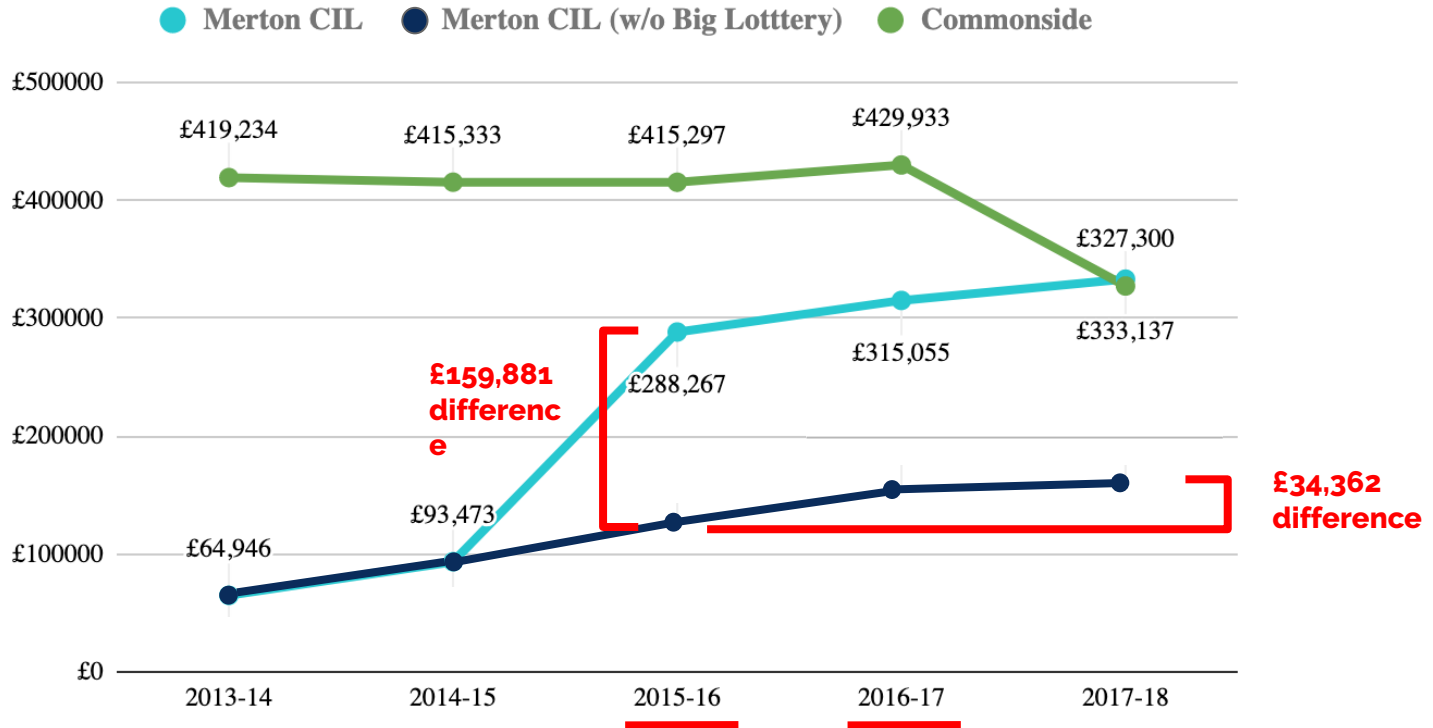

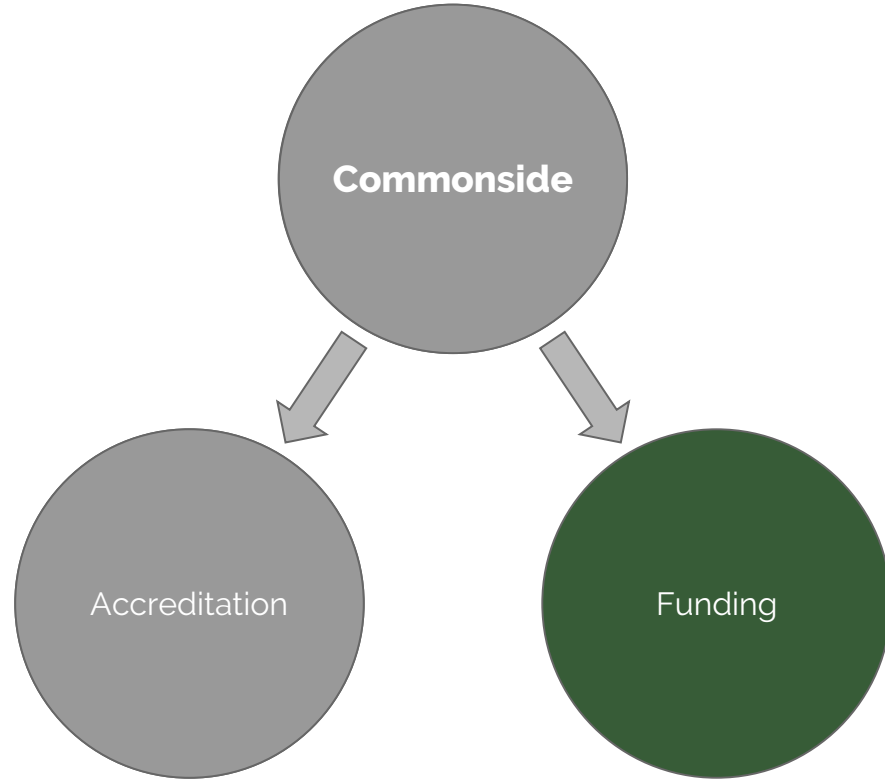

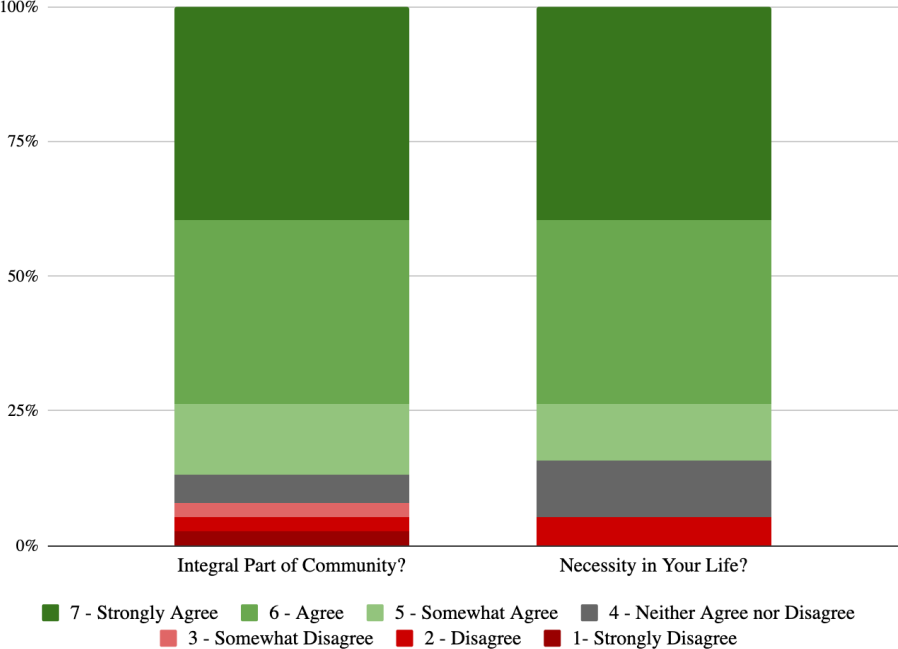

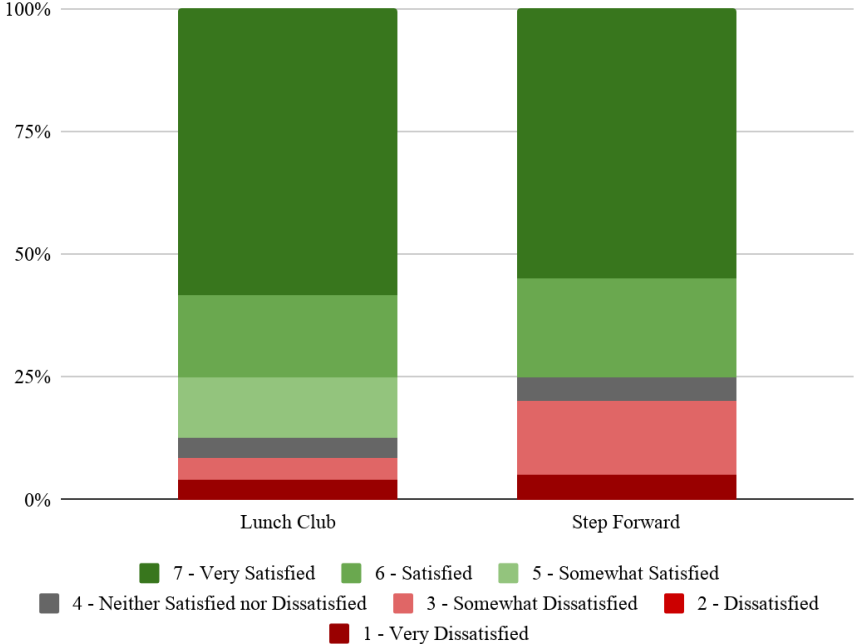
Clients were asked if they considered Commonside to be...

Total responses: 35, 35

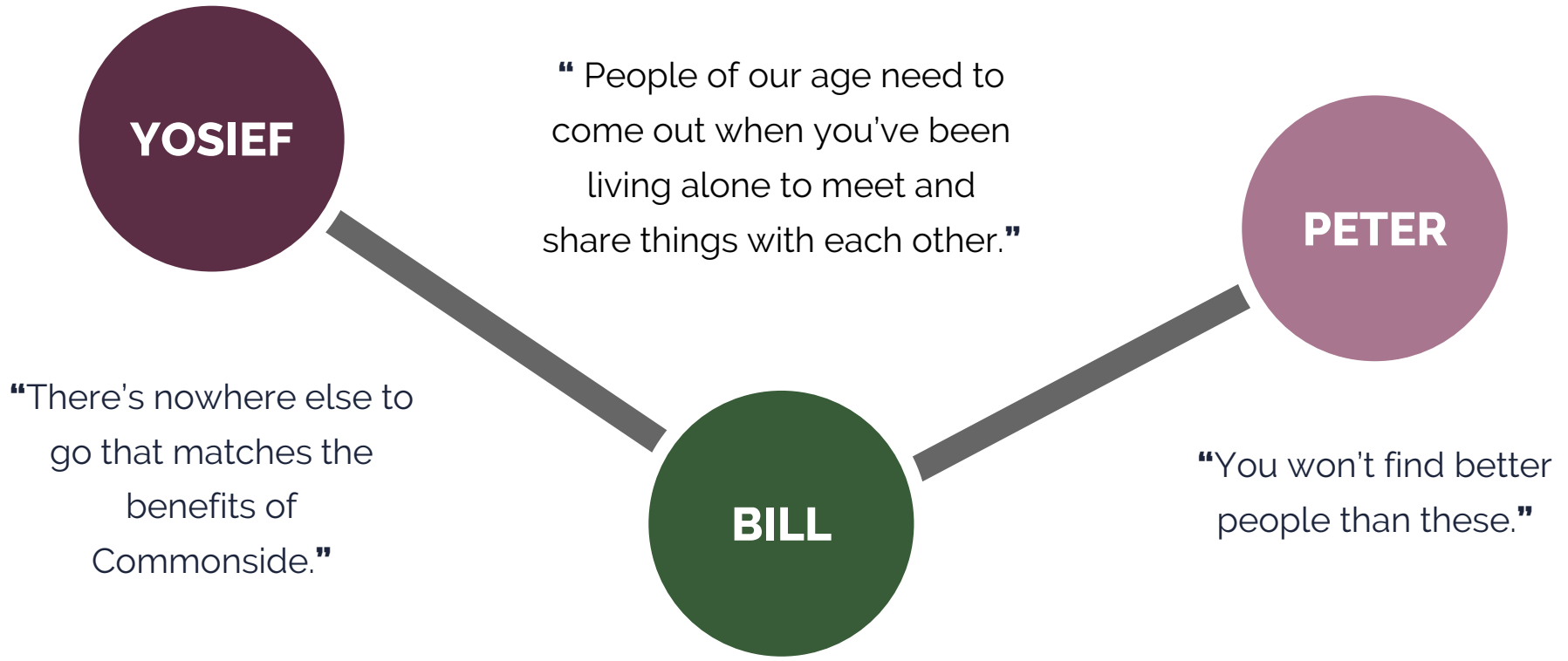


Lunch Club and Step Forward

Low-Hanging Fruit

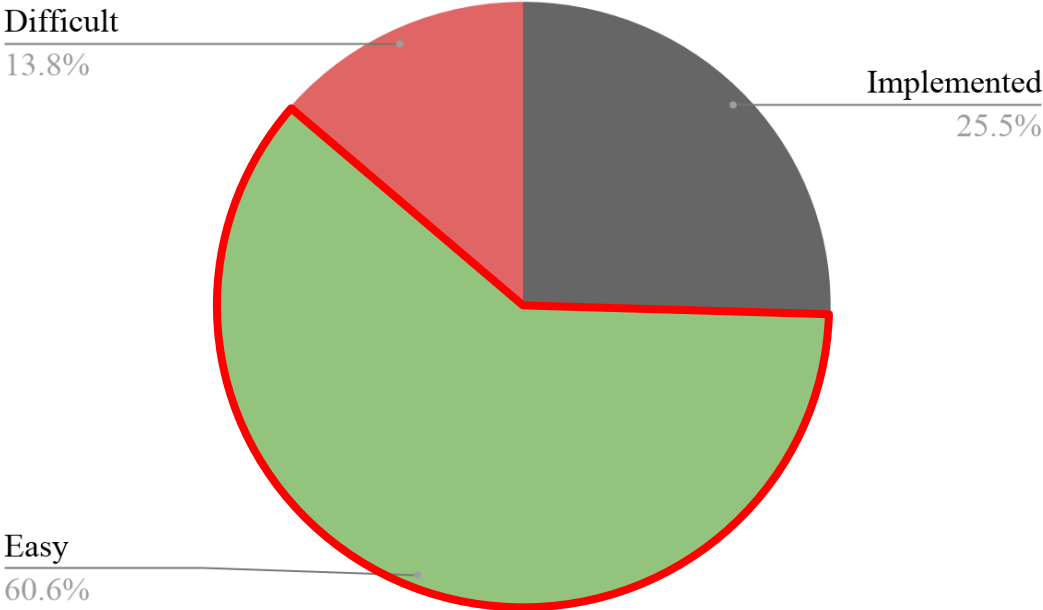

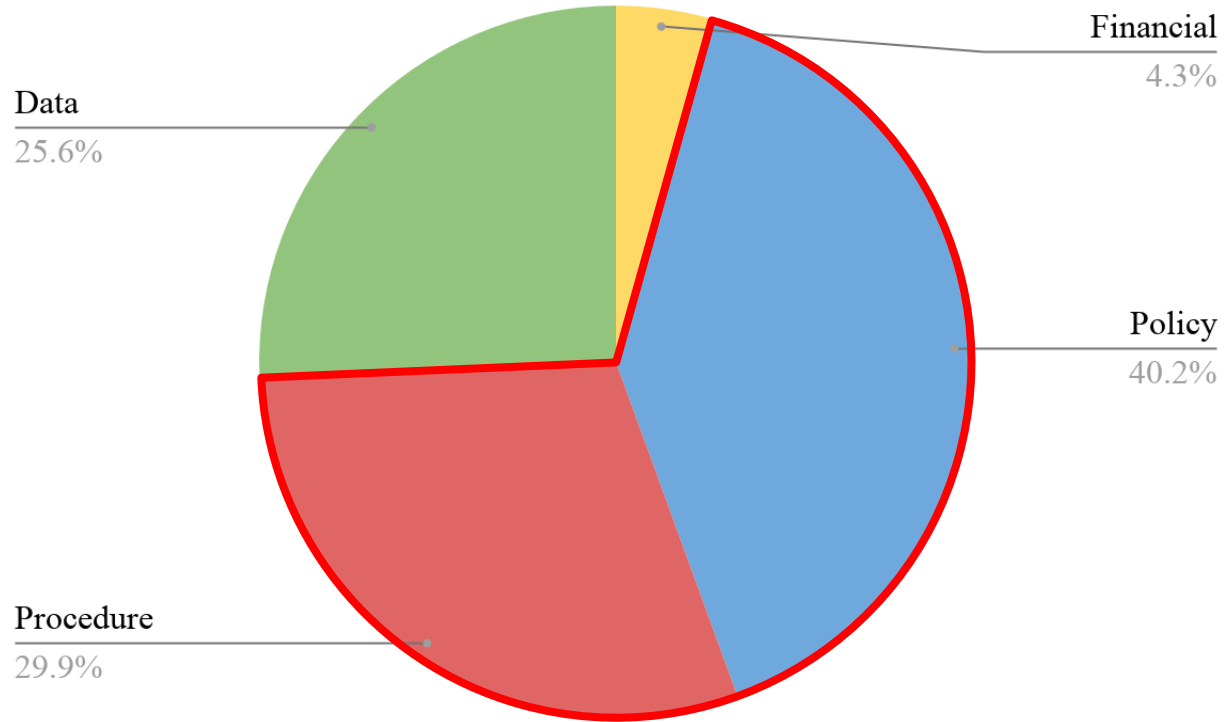


Bang for the Buck

1. Appoint individual to **oversee the quality** processes.

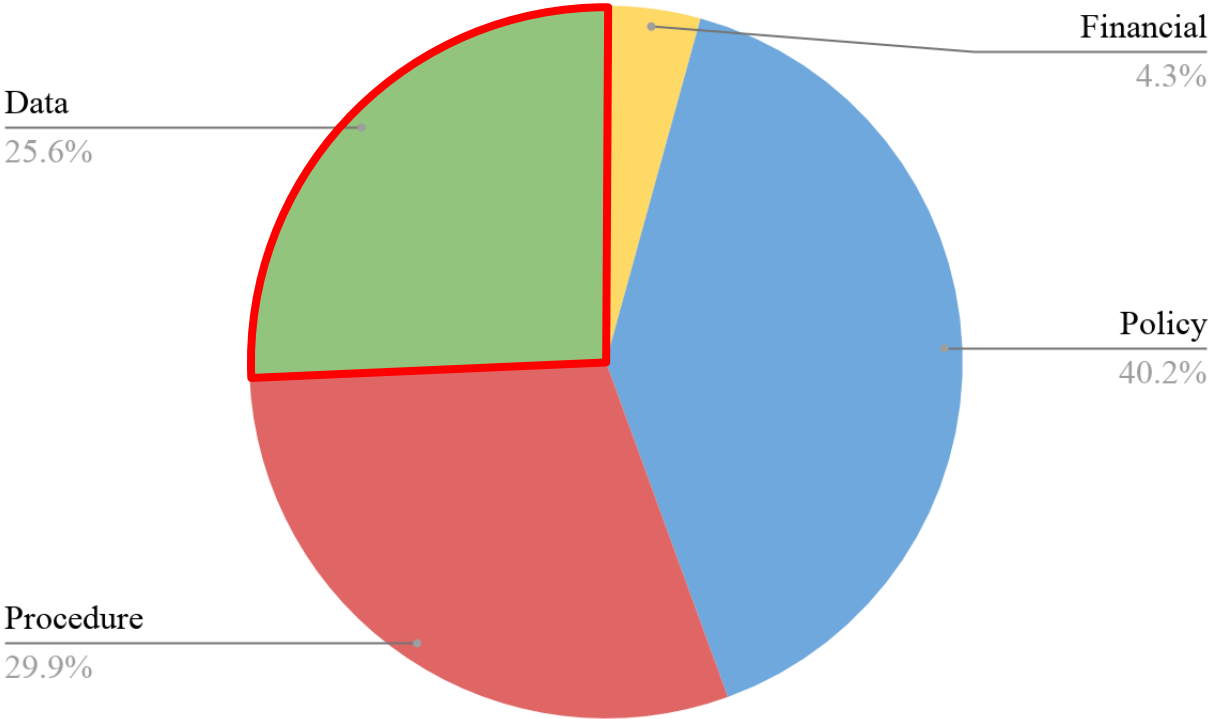
2. Addition of a **Conflict of Interest** policy.
