Policy and Procedure

Easy to Complete but **Low-Impact** and **Time Consuming**



Critical Policies and Procedures

A form of these should exist regardless.

- Policy regarding the **type of work they do** for funders, organizations, and the public
- Appoint Individual to **oversee the quality** processes
- Addition of a **Conflict of Interest** policy



Critical Policies and Procedures

- Written procedure **matching employee skills** to roles
- Policy to identify at least **one person responsible for supervising** staff and volunteers
- Policy to ensure **privacy in meeting** with clients, where required

Features List

Accessible

Want to get back to helping others? The database must be easy to learn and simple to use.

Secure and Encrypted

It's paramount that client data is secure and encrypted!

Backed Up

When things aren't on paper, it's always good to have a copy somewhere, just in case.

Searchable

Say you want to know how many clients were referred to organization X...

Exportable

Well, organization X might need those client files for your need client.

Access Control

For my eyes only! Permissions are required so volunteers and staff aren't allowed to see the same data.

Keep an **Open Mind!**

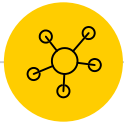
Adjustment to any new system can be hectic, annoying, and a number of other things.
